PROFESSIONAL BACKGROUND

Tony is an experienced dispute resolution lawyer with an acute understanding of the problems and pitfalls of the judicial system. He is a passionate advocate of the use of negotiation and mediation in the resolution of disputes and is particularly interested in the psychology of conflict resolution.

Tony was accredited as a mediator with the ADR Group in 1999 and since then has acted as lead mediator, co-mediator, observer and party adviser in a wide range of mediations, specialising in the resolution of commercial disputes. He has frequently given presentations on the use of mediation and has facilitated courses on mediation techniques for new and experienced mediators. He has been a judge in the UK Student Mediation Competition and in the University of the West of England Student Mediation Competition. He is currently Registrar and Vice Chair of the Association of Southwest Mediators (“ASWM”).

When not mediating, Tony runs his own legal practice which handles a wide range of commercial, corporate and employment disputes.
